

## **CHAPTER 9**

### **ELECTIONS**

#### **Sec. 9-1.      Election of Supervisors.**

The Board of Supervisors of Bath County shall consist of five (5) members who shall be residents of designated election districts. There shall be one (1) supervisor elected from each election district. Each supervisor shall be elected from his or her respective election district by a plurality of the votes cast in his or her election district as shown by the books of the registrar.

At the general election to be conducted in November 2023, two members of the Board of Supervisors shall be elected for terms of two (2) years each. The remaining three members of the Board of Supervisors shall be elected for terms of four (4) years. Unless there are sufficient members who volunteer to take two-year terms, the Electoral Board of Bath County shall assign the individual terms of members by lot at its meeting on the day following the election and immediately upon certification of the results. However, the Electoral Board may assign individual terms of members by election district in a drawing at a meeting held prior to the last day for a person to qualify as a candidate, if the Board of Supervisors so directs by ordinance or resolution adopted at least thirty days prior to the last day for qualification. In all elections thereafter all successful candidates shall be elected for terms of four years.

#### **Sec 9-2.      Election of School Board.**

The School Board of Bath County shall be an elected school board, which shall consist of five (5) members, who shall be elected by the registered voters of Bath County for terms of four (4) years each. Election of school board members shall coincide with the election of members of the Board of Supervisors and shall take place at the regular general election held in November. One school board member shall be elected from each

of the five election districts, which shall be coterminous with the election districts for the election of members of the Board of Supervisors for the County. The terms of office for the elected school board members shall commence on January 1 following their election. The terms of office for members of the school board in office through appointment shall expire on December 31 of the year of the election of the school board members replacing them. School Board members shall be qualified voters and residents of the election district from which they are elected.

At the general election to be conducted in November 2023, two members of the School Board shall be elected for terms of two years each to correspond with the election of the County supervisors herein. The remaining three members of the School Board shall be elected for terms of four (4) years. In all elections thereafter, all successful candidates for the School Board shall be elected for terms of four years.

### **Sec. 9-3.      Election districts.**

Pursuant to the authority contained in the Constitution of the Commonwealth of Virginia, and in Section 24.2-304.1 et seq., and Section 24.2-305 et seq. of the 1950 Code of Virginia, as amended, the County of Bath shall have the following Magisterial Districts which shall also be known as, and are hereby designated as, election districts: Valley Springs District, Cedar Creek District, Warm Springs District, Williamsville District, and Millboro District.

### **Sec. 9-4.      Same-boundaries.**

The boundaries of the above Magisterial Districts according to the redistricting required in 2021, following the Census of 2020, are described and shown on that certain plat entitled “Bath County, Virginia – Magisterial Districts and Voting Precincts Map, 2021”, prepared by King-Moore, Inc. for the Bath County Board of Supervisors, January 21, 2022. Sources: U.S. Census Bureau, 2020 TIGER Census Data and Bath County, Virginia, which is hereby adopted by reference. The boundaries of the respective Magisterial (“Election”) Districts according to said map are set forth as follows:

## **PRELIMINARY STATEMENT**

By Order of the Honorable Earl L. Abbott, Judge of the Circuit Court of Bath County, Virginia, entered on January 2, 1969, of record in Law Order Book 13, at Page 94, and in Deed Book 80, at Page 135, Bath County was reapportioned into 5 Magisterial

(Election) Districts. References to the boundary lines for Districts and Precincts were established by the 1991 Redistricting Ordinance and the 1993 Redistricting Ordinance. The 2001 Redistricting Ordinance Amendment established boundaries of the Districts and Precincts by use of the 2000 Census Map for Bath County, Virginia, County Block Map (2000), Bath County, Virginia. The 2011 Redistricting Ordinance Amendment established boundaries of the Districts and Precincts by use of the 2010 Census Block Map of Bath County, Virginia. The 2021 Redistricting Ordinance Amendment established boundaries of the Districts and Precincts by use of the 2020 Census Block Map of Bath County, Virginia.

## **VALLEY SPRINGS MAGISTERIAL DISTRICT**

Beginning at a point where Little Wilson Creek intersects a point shared by the Williamsville, Cedar Creek, and Valley Springs Districts, also being the point shared by Census Blocks 1001, 1036, and 3000; thence in a westerly direction with the center of Little Wilson Creek to its intersection at a point where census blocks 1036 and 3000 intersection with the head waters of Little Wilson Creek; thence following the northern edge of Census block 3000 westerly to a point where it intersects with Delafield Road East; thence following Delafield Road East westerly to its intersection with Delafield Road West; thence following Delafield Road West in a northerly and westerly direction to its intersection with Ski Lodge Drive; thence following Ski Lodge Drive to its intersection with Homestead Drive; thence in a southerly direction along Homestead Dr to its intersection with Shady Lane; thence with the centerline of Shady Lane in a southerly direction to its intersection with State Route 658/Park Lane; thence following State Route 658/Park Ln northwesterly to its intersection with US Highway 220/Sam Snead Hwy; thence in a northerly direction with the centerline of US Highway 220/Sam Snead Hwy to its intersection with Old Green House Road; thence 345 feet in a westerly direction with the centerline of Old Green House road to its intersection with a point shared by Census Blocks 2062 and 2063; thence in a westerly direction following the northern boundary of Census Block 2063 to its intersection point of census blocks 2063, 2061, and 2064; thence following the northern edge of census block 2064 northwesterly to an intersection point of census blocks 2061, 2064, 2059, and 2058; thence following the eastern edge of census block 2058 northerly and then southerly to a point of intersection of census blocks 2058, 2053, 2049, and 2064; thence following the eastern edge of census block 2064 southerly to a point of intersection of census blocks 2064, 2049, 2045, and 2052; thence following the southern edge of census block 2052 northwesterly to a point that intersects Cascades Gorge Road; thence following Cascades Gorge Road northwesterly to its terminus; thence following the northwestern edge of census block 2045 southwesterly to the intersection with Lower Cascades Dr; thence following Lower Cascades Drive southwesterly to its intersection with State Route 687/Jackson River Tpke; thence following State Route 687/Jackson River Tpke 0.41 miles south to an point that intersects with an unnamed drive at the intersection of census blocks 2044, 2047, and 2045; thence following the eastern edge of census block 2045 southerly to an intersection with Lost Cabin Road; thence following Lost Cabin Road

westerly to its intersection with State Route 687/Jackson River Tpke; thence following State Route 687/Jackson River Tpke 0.15 miles south to a point at the intersection of census blocks 2044, 2045, and 2070; thence following the northern edge of census block 2070 in a southwesterly direction to a point of intersection of census blocks 2044, 2030, and 2070; thence following the eastern edge of census block 2070 southerly to the intersection with Bath County/ Alleghany County Line; thence following the Bath County/ Alleghany County Line easterly to the intersection with Williamsville District at the intersection point of census blocks 1049, 3009, and the Bath County Line; thence following the eastern edge of census block 3009 northerly the to the intersection of census blocks 3000, 1049, and 3009; thence following the western edge of census block 3009 northerly to the intersection of census blocks 1049, 3009, 1035, and 3000; thence following the eastern edge of census block 3000 northerly to the Point of Beginning.

## **CEDAR CREEK MAGISTERIAL DISTRICT**

Beginning at a point where Little Wilson Creek intersects a point shared by the Williamsville, Cedar Creek, and Valley Springs Districts, also being the point shared by Census Blocks 1001, 1036, and 3000; thence in a northerly direction following the eastern border of Census Block 1036 to its intersection with a vehicular trail, also being a point shared by Census Blocks 1036, 1012, and 1003; thence in a northerly direction following the eastern border of Census Block 1003 to its intersection with Homestead Skyline Drive; thence in a northerly direction following the centerline of Homestead Skyline Drive to its intersection with a point on said road that is shared by Census Blocks 1003, 1012, 1018; thence in a westerly direction following the northern border of Census Block 1012 to its intersection with US Highway Route 220/Sam Snead Hwy; thence northerly with US Highway Route 220/Sam Snead Hwy for 1.52 miles to its intersection with a point shared by census blocks 1018, 1021, and 1006; thence following the northern boundary of census block 1021 2.67 miles in northwesterly direction then turning west to its intersection with a point where census blocks 1021, 1022 and 1008 intersect; thence following the northern border of census block 1022 west to its intersection with State Route 687/Jackson River Tpke; thence following State Route 687/Jackson River Tpke southwesterly to its intersection with State Route 603/Richardson Gorge Road; thence in a southwesterly direction following the centerline of State Route 603/Richardson Gorge Road to its intersection with the eastern side of Lake Moomaw/Jackson River; thence following the eastern side of Lake Moomaw/Jackson River south to the intersection with the Bath County/Alleghany County Line; thence following the Bath County/ Alleghany County Line east to intersection with Cedar Creek; thence following Cedar Creek 0.64 miles northerly to intersection with unnamed stream; thence following unnamed stream northeasterly to its intersection with State Route 687/Jackson River Tpke; thence northerly with State Route 687/Jackson River Tpke to its intersection with Lost Cabin Road; thence easterly with Lost Cabin Road to intersection with unnamed drive and the intersection of census blocks 2045 and 2047; thence following the eastern edge of census block 2047 north and northwest to the intersection with State Route 687/Jackson River

Tpke; thence north with State Route 687/Jackson River Tpke to its intersection with Lower Cascades Drive; thence northeasterly with Lower Cascades Drive 0.6 miles to intersection with unnamed drive and intersection with census blocks 2028 and 2045; thence following the northwestern edge of census block 2045 northeast to the intersection at the western terminus of Cascades Gorge Road; thence following Cascades Gorge Road southeasterly to its intersection with census blocks 2049, 2045, and 2052; thence following the southern edge of census block 2052 to its intersection with Cascades Gorge Road and intersection of census blocks 2045, 2049, 2052, and 2064; thence following the western edge of census block 2064 northeasterly to the intersection of census blocks 2064, 2049, 2053, 2058; thence following the western edge of census block 2058 northeasterly then southeasterly to the intersection of census blocks 2058, 2059, 2061, and 2064; thence following the northeastern edge of census block 2064 southeasterly to the intersection of census blocks 2064, 2061, 2062, and 2063; thence following the northern edge of census block 2063 easterly to the intersection with Old Greenhouse Road; thence following Old Greenhouse Road easterly to its intersection with US Highway 220/Sam Snead Hwy; thence following US Highway 220/Sam Snead Hwy south to its intersection with State Route 658/Park Lane; thence following State Route 658/Park Lane southeasterly to its intersection with Shady Lane; thence Shady Lane north to its intersection with Homestead Drive; thence following Homestead Drive north to its intersection with Ski Lodge Drive; thence following Ski Lodge Drive to its intersection with Delafield Road West; thence following Delafield Road West easterly and southerly to its intersection with Delefield Road East; thence following Delefield Road East easterly to a point where census blocks 3001, 1012, 3000, and 1036 intersect; thence following the southern edge of census block 1036 easterly to its intersection with Little Wilson Creek; thence following Little Wilson Creek east to the point of beginning.

#### **WARM SPRINGS MAGISTERIAL DISTRICT**

Beginning at a point on the Bath-Highland County line where said line intersects State Route 600/Big Back Creek Road thence in a northwesterly direction with the Bath-Highland County line to its intersection with the West Virginia State line; thence in a southwesterly direction following the Virginia-West Virginia State line to its intersection with the West Virginia-Bath-Allegany County lines; thence in an easterly direction following with the Bath-Allegany County line to its intersection with the eastern side of the Lake Moomaw also being the intersection of census blocks 2032 and 2033; thence following the eastern edge of Lake Moomaw and census block 2033 northerly to its intersection with State Route 603/Richardson Gorge Road; thence following State Route 603/Richardson Gorge Road northeasterly to its intersection with State Route 687/Jackson River Tpke; thence following State Route 687/Jackson River Tpke 1.2 miles to a point where census blocks 1022, 2021, 2022, and 1008 intersection with State Route 687; thence following the southern edge of census block 1008 to a point where census blocks 1008, 1021, and 1007 intersect; thence following the northern edge of census block 1021 to where it intersects with US Route 220/Sam Snead Hwy; thence following US Route 220/Sam Snead Hwy south to a point where census blocks 1021, 1018, 1027,

and 1012 intersect with US Route 220; thence following the southern edge of census block 1018 easterly to the intersection of Williamsville, Cedar Creek, and Warm Springs where census blocks 1018, 1012, and 1003 intersect; thence following the eastern edge of census block 1018 northerly to the intersection of census blocks 1018, 1003, and 1004; thence following the eastern edge of census block 1004 northerly to its intersection with State Route 39/Mountain Valley Road; thence following State Route 39/Mountain Valley Road westerly to its intersection with US Route 220/Sam Snead Hwy; thence following US Route 220/Sam Snead Hwy northerly to a point where census blocks 2063, 2136, and 2064 intersect; thence following the eastern edge of census block 2064 northerly back to the intersection with US Route 220/Sam Snead Hwy; thence following US Route 220/Sam Snead Hwy northerly to its intersection with Chimney Run Farm Road; thence following Chimney Run Farm Road northeasterly to its terminus and the intersection of Chimney Run Farm Road, census block 2063, and census block 2145; thence following the eastern edge of census block 2145 northerly to a point where census blocks 2145, 2063, and 2144 intersect; thence following the eastern edge of census block 2144 northwesterly to its intersection with US Route 220/Sam Snead Hwy; thence following US Route 220/Sam Snead Hwy northerly to its intersection with State Route 614/Muddy Run Road; thence following State Route 614/Muddy Run Road northerly to a point where census blocks 2146, 2063, and 2014 intersect; thence following the western edge of census block 2014 northerly to its intersection with Duncan Knob Road; thence following Duncan Knob Road northwesterly to a point where it and census blocks 2014 2017 intersect; thence following the eastern edge of census block 2017 northerly to a point where census blocks 2017, 2014, and 2016 intersect; thence following the eastern edge of census block 2016 northerly to where it intersects with the Bath County/Highland County Line; thence following the Bath County/Highland County Line westerly to its intersection with State Route 600/Big Back Creek Road, also the point of beginning.

## **WILLIAMSVILLE MAGISTERIAL DISTRICT**

Beginning at a point where Little Wilson Creek intersects a point shared by the Williamsville, Cedar Creek, and Valley Springs Districts, also being the point shared by Census Blocks 1018, 1012, and 1003; thence following the western edge of census block 1003 southerly to a point where census blocks 1003, 1036, and 1001 intersect; thence following the western edge of census block 1001 southerly to a point where census blocks 1001, 3000, and 1035 intersect; thence following the western edge of census block 1035 southerly to a point where census blocks 1035, 3000, 3009, and 1049 intersect; thence following the western edge of census block 1049 southerly to where it intersects with the Bath County/Alleghany County Line; thence following the Bath County/Alleghany County Line east to a point where it intersects with the intersection of census blocks 1043 and 1049; thence following the eastern edge of census block 1049 northerly to a point where census blocks 1049, 1043, and 1047 intersect; thence following the western edge of census block 1047 northerly to the point where census blocks 1047, 1051, 1052, and 1038 intersect; thence following the western edge of census block 1038 northerly to where it intersects with State Route 39/Mountain Valley Road;

thence following State Route 39/Mountain Valley Road east to its intersection with Thomson Creek; thence following Thompson Creek easterly to its intersection with Cowpasture River; thence following Cowpasture River northeasterly to its intersection with State Route 629/Deerfield Road; thence following State Route 629/Deerfield Road easterly to a point where census blocks 2119, 2120, and 2122 intersect; thence following the eastern edge of census block 2122 northerly then southeasterly to a point where census blocks 2122, 2092, 2119 and State Route 629/Deerfield Road intersect; thence following the southern edge of census block 2092 southeasterly to a point where it intersects with State Route 678 and census blocks 2111, 2124, and 2114; thence following the eastern edge of census block 2114 northerly to a point where Thornhill Drive and census blocks 2114, 2111, and 2112 intersect; thence following the eastern edge of census block 2112 northerly to a point where it intersects with Stuart Run and the intersection of census blocks 2112, 2113, 2117, and 2093; thence following the eastern edge of census block 2093 northerly to a point where census blocks 2093, 2117, 2107, and 2094 intersect; thence following the eastern edge of census block 2094 to a point where census blocks 2094, 2107, 2106, and 2095 intersect at State Route 633/Pig Run Road; thence following the southern edge of census block 2095 easterly to its intersection with State Route 640 and census blocks 2103, 2104, and 2100; thence following the southern edge of census block 2100 easterly to a point where it intersects Forest Road 61; thence following Forest Road 61 northeasterly to a point where census blocks 2100, 2102, and 2101 intersect; thence following the southern edge of census block 2101 easterly to its intersection with Bath County/Rockbridge County Line; thence the Bath County/Rockbridge County Line northerly to the intersection of Bath County/Rockbridge County/Augusta County Line; thence following the Bath County/Augusta County Line northerly and then westerly to the point of intersection of Bath County/Augusta County/Highland County Line; thence following the Bath County/Highland County Line westerly to a point where census blocks 2016 and 2014 intersect at the county line also known as the ridge line of Jack Mountain; thence south along Jack Mountain ridgeline and following the western edge of census block 2014 southerly to a point it intersects with State Route 614/Muddy Run Road; thence following State Route 614/Muddy Run Road southwesterly to its intersection with US Route 220/Sam Snead Hwy; thence following US Route 220/Sam Snead Hwy southwesterly to a point where census blocks 2142, 2144, and 2063 intersect; thence following the western edge of census block 2063 southeasterly to a point at the terminus of Chimney Run Farm Road; thence following Chimney Run Farm Road southwesterly to its intersection with US Route 220/Sam Snead Hwy; thence following US Route 220/Sam Snead Hwy south to its intersection with census blocks 2136, 2064, and 2063; thence following the western edge of census block 2063 southerly to its intersection with US Route 220/Sam Snead Hwy; thence following US Route 220/Sam Snead Hwy south to its intersection with State Route 39/Mountain Valley Road; thence following State Route 39/Mountain Valley Road southeasterly to a point where census blocks 1004, 2079, and 1003 intersect; thence following the western edge of census block 1003 southerly to the point of beginning.

## **MILLBORO MAGISTERIAL DISTRICT**

Beginning at a point on the Bath-Alleghany County line and its intersection with the eastern boundary of Douthat State Park; thence in an easterly direction following the Bath-Alleghany County line to the southernmost point of the County on Mill Mountain; thence in a northerly direction following the same Bath-Alleghany County line to a point shared by the Bath-Alleghany-Rockbridge County lines; thence in a northerly direction following the Bath-Rockbridge County line to a point on the ridge line of Sideling Hill where the eastern borders of Census Blocks 2101 and 2102 intersect; thence following the northern edge of census block 2102 to the intersection with Forest Road 61; thence following Forest Road 61 southwesterly 150 feet to the intersection with census blocks 2100, 2104, and 2102; thence following the northern edge of census block 2104 westerly to its intersection with State Route 640/Mill Creek Road and the intersection with census blocks 2097 and 2103; thence following the northern edge of census block 2103 westerly to where census blocks 2103, 2095, and 2130 intersect; thence following the southern edge of census block 2095 westerly to where it intersects with State Route 633/Pig Run Road and also the intersection of census blocks 2106, 2095, 2094, and 2107; thence following the western edge of census block 2107 southerly to a point where census blocks 2107, 2094, 2093, and 2117 intersect; thence following the western edge of census block 2117 southerly to intersection with Stuart Run and census blocks 2112 and 2111; thence following the western edge of census block 2111 southerly past intersection with Thornhill Drive and continuing to intersection with State Route 678/Indian Draft Road and also the intersection with census blocks 2111, 2114, 2092, and 2124; thence following the southern edge of census block 2092 westerly to intersection with State Route 629/Deerfield Road and census blocks 2120 and 2122; thence following the western edge of census block 2120 west then southwesterly to intersection with State Route 629/Deerfield Road; thence following State Route 629/Deerfield Road westerly to its intersection with Cowpasture River; thence following Cowpasture River southwesterly to its intersection with Thompson Creek; thence following Thompson Creek westerly to its intersection with State Route 39/Mountain Valley Road; thence following State Route 39/Mountain Valley Road westerly to a point where it intersects at the intersection of census blocks 1040, 2132, and 1038; thence following the western edge of census block 1038 southerly to a point where census blocks 1038, 1052, 1051, and 1047 intersect; thence following the western edge of census block 1047 southerly to a point where census blocks 1047, 1049, and 1043 intersect; thence following the western edge of census block 1043 southerly to the point of beginning.

## **CENTRAL ABSENTEE PRECINCT**

There is hereby established a permanent Central Absentee Precinct to serve the entire County of Bath to be used for all elections. The polling place for such precinct shall be located in the Courthouse at Courthouse Hill, Warm Springs, Virginia 24484.

### **Sec. 9-5. Precincts-names and polling places**

The boundaries of the respective precincts and their polling places are set forth as follows:

(1) Cedar Creek District, Valley Springs District, and Millboro District shall each be single precinct districts. Voting places within each of these districts shall be as follows:

Cedar Creek Precinct – Hot Springs Volunteer Fire Department and Rescue Building

Valley Springs Precinct – Ashwood United Methodist Church

Millboro Precinct – Millboro Ruritan Club

(2) The precincts located within the Warm Springs District and their voting places shall be as follows:

Mountain Grove Precinct – Mountain Grove Community Center

Warm Springs Precinct – Mountain Crest Retirement Home Community Center<sup>1</sup>

(3) The precincts located within the Williamsville District and their voting places are as follows:

Burnsville Precinct – Burnsville United Methodist Church<sup>2</sup>

Fairview Precinct – Fairview Community Center

(4) The Central Absentee Precinct (CAP) serving the entire County of Bath shall have one voting place as follows: Central Absentee Precinct (CAP) – Bath County Courthouse.<sup>3</sup>

<sup>1</sup> The polling place for Warm Springs Precinct was changed from Warm Springs Presbyterian Church to Mountain Crest Retirement Home Community Center by ordinance passed by the Bath County Board of Supervisors dated December 12, 2023.

<sup>2</sup> The polling place for the Burnsville Precinct was changed from the Burnsville “Cavern Valley” Community Center to the Burnsville United Methodist Church by ordinance passed by the Bath County Board of Supervisors dated June 13, 2023. However, Bath County Code § 9-5 has not yet been updated to reflect that change. Bath County Code § 9-5 will now be updated to reflect the changes to both the Warm Springs Precinct and Burnsville Precinct polling places.

<sup>3</sup> The word “Circuit” is being removed because the Bath County Courthouse houses both the General District Court and the Circuit Court for the County of Bath, Virginia.

### **MOUNTAIN GROVE PRECINCT OF WARM SPRINGS DISTRICT**
